1. Definition

The Department for Education introduced compulsory Relationships and Sex Education (RSE) for secondary pupils in September 2020. From the same date, it also became compulsory for all schools to teach Health Education.

The Relationships, Sex and Health Education (RSHE) curriculum at Barr's Hill School has been designed and developed in response to the DfE's changes and covers the core content of both Relationships and Sex Education (RSE) and Health Education.

RSHE at Barr's Hill is about supporting the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSHE involves a combination of sharing information, and exploring issues and values through discussion.

RSHE is not about the promotion of sexual activity.

As written in section 76 of the DfE's statutory guidance for RSE, 'It is recognised that there will be a range of opinions regarding RSE. The starting principle when teaching each of these must be that the applicable law should be taught in a factual way so that pupils are clear on their rights and responsibilities as citizens.'

2. Aims

The aims of Relationships, Sex and Health Education (RSHE) at Barr's Hill School are to:

- Help students to grow up healthy, happy, safe and feeling confident in their ability to manage future challenges and opportunities
- To equip students with the knowledge to make informed decisions about their wellbeing, health and relationships, preparing them for a successful adult life
- Help pupils develop good character, including feelings of self-respect, kindness confidence, empathy and consideration of others
- Help children achieve self-discipline and commitment so that they reach the highest standards of which they are capable
- Encourage children to take an active and responsible role in their learning
- Students should understand the society in which they are growing up from a factual point of view, including the protected characteristics as outlined in the [Equality Act 2010](#).

The aims above are underpinned by PRIDE – Barr's Hill's core set of values and behavioural expectations that we promote to all students. Through PRIDE, we encourage students to be:

- Proactive
- Responsible
- Inquisitive
- Determined
- Engaged

Through PRIDE and our RSHE curriculum we aim for students to foster respect for others and for difference, and educate pupils about healthy relationships. RSE should meet the needs of all pupils, whatever their background – this should include age-appropriate teaching about different types of relationships in the context of the law.

3. Statutory Requirements

As a secondary academy school we must provide RSHE to all pupils as per section 34 of the [Children and Social work act 2017](#).

In teaching RSHE, we are required by our funding agreements to have regard to [guidance](#) issued by the secretary of state as outlined in section 403 of the [Education Act 1996](#).

At Barr's Hill School we teach RSHE as set out in this policy.

4. Policy Development

This policy has been developed in consultation with staff, pupils and parents. The consultation and policy development process involved the following steps:

1. Review – RSHE leads pulled together all relevant information including relevant national and local guidance
2. Staff consultation – a staff working group made up of colleagues from each Hub was given the opportunity to look at the policy and make recommendations
3. Parent/stakeholder consultation – parents and any interested parties were invited to attend a meeting about the policy
4. Pupil consultation – we investigated what pupils want from their RSHE through survey data in addition to pupil voice
5. Ratification – once amendments were made, the policy was shared with governors and ratified

5. Curriculum

Our RSHE curriculum overview is set out as per Appendix 1 but may need to be adapted as and when necessary, in accordance with pupil needs, local and global issues etc. The curriculum has been designed to meet the end points outlined in the [guidance](#) issued by the secretary of state on 25 June 2019.

We have developed the curriculum in consultation with parents, pupils and staff, taking into account the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and do not seek answers online.

6. Delivery of RSHE

RSHE is taught within Barr's Hill School's Personal Development Curriculum. As such, content is delivered through the tutorial programme, 'standstill lessons', 'Deeper Learning Days' during INSPIRE Week and through the academic curriculum by both Hub and Faculty teams. Biological aspects of RSHE are taught within the science curriculum, and other aspects are included in Religious Education (RE) and English. See appendix 1 for more information.

*In accordance with our curriculum plan, pupils will receive stand-alone RSHE sessions on certain topics and these will be delivered during the school day during lesson time. These sessions may be facilitated by Barr's Hill staff or by trained external professionals or specialists, e.g. a dentist may provide a session related to oral hygiene.

The topics covered within our RSHE curriculum focus on

- 1) Giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:
 - Families
 - Respectful relationships, including friendships
 - Online and media
 - Being safe
 - Intimate and sexual relationships, including sexual health
- 2) Giving young people the information they need to enable them to make well-informed, positive choices for themselves about:
 - Mental wellbeing
 - Internet safety and harms
 - Physical health and fitness
 - Healthy Eating
 - Drugs Alcohol and Tobacco
 - Health and prevention
 - Basic First Aid
 - Changing adolescent body

For more information about our RSHE curriculum and how each of the DfE end points will be met, see Appendices 1 and 2.

These areas of learning are taught within the context of family life, taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

Coventry Local Authority have given their support to all Coventry schools to include learning about LGBT+ appropriately as part of the statutory curriculum, in accordance with the Equality Act 2010, and protect their right and duty to do so. For more information, please see their full statement at Appendix 3.

7. Roles and responsibilities

7.1 The governing board

The governing board will approve the RSHE policy, and hold the headteacher to account for its implementation.

7.2 The headteacher

The headteacher is responsible for ensuring that RSHE is taught consistently across the school, and for managing requests to withdraw pupils from non-statutory components of Sex Education (see section 8).

7.3 Staff

Staff are responsible for:

- Delivering RSHE in a sensitive way
- Modelling positive attitudes to RSHE
- Monitoring progress
- Responding to the needs of individual pupils
- Responding appropriately to pupils whose parents wish them to be withdrawn from the non-statutory components of Sex Education.
- Encouraging students to speak respectfully and listen to viewpoints they may not agree with

Staff do not have the right to opt out of teaching RSHE. Staff who have concerns about teaching RSHE are encouraged to discuss this with the RSHE working group or the headteacher.

7.4 Pupils

Pupils are expected to engage fully in RSHE and, when discussing issues related to RSHE, treat others with respect and sensitivity.

8. Parents' right to withdraw

New legislation brought in through the Children and Social Work Act 2017 brought changes in relation to parental rights to withdraw children from school sex education.

Parents do not have the right to withdraw their child from the elements of our RSHE Curriculum that also feature in the National Science Curriculum. This is the biological aspects of human growth and reproduction.

Parents do have the right to withdraw their child from the non-science components of Sex Education within RSHE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this.

Requests for withdrawal should be put in writing using the form found in Appendix 3 of this policy and addressed to the headteacher.

A copy of withdrawal requests will be placed in the pupil's educational record. The headteacher will discuss the request with parents and take appropriate action.

Alternative work will be given to pupils who are withdrawn from sex education.

9. Training

Staff are trained on the delivery of RSHE and it is included in our continuing professional development calendar.

Specialist visitors from outside the school, such as school nurses or sexual health professionals, will be invited to provide additional support and training to staff teaching RSHE if and when required.

10. Monitoring Arrangements

The delivery of RSHE through Hub and faculty teams will be monitored by the Associate Assistant Headteacher – Personal Development through:

- Review of Hub and Faculty plans
- Meetings with Hub Directors and Heads of Faculties responsible for delivering RSHE
- Meetings with other post-holders responsible for design and delivery of Personal Development curriculum
- RSHE Learning walks and drop-in sessions
- Gaining pupil feedback through end of topic evaluation forms
- Ongoing monitoring and feedback by class teachers as part of internal assessment systems
- parental feedback through planned focus groups

This policy will be reviewed by Associate Assistant Headteacher – Personal Development annually. At every review, the policy will be approved by the headteacher.

LA Supporting guidance for LGBT+ in Coventry schools

Guidance Statement LGBT+

Coventry is an increasingly diverse and vibrant city with a global reputation for peace and reconciliation, which we celebrate. It is within this context that we are supporting Coventry schools to ensure that the emotional health and educational needs of all pupils and their families are appropriately met.

As a Local Authority, in partnership with local unions and other key stakeholders, we support Coventry schools in delivering inclusive Relationships and Sex Education to teach all members of the school community about mutual respect and tolerance for each other.

Therefore, we support all Coventry schools to include learning about LGBT+ appropriately as part of the statutory curriculum, in accordance with the Equality Act 2010, and protect their right and duty to do so.

School leaders should have: -

- Consultation with governors
- Consulted with faith leaders
- Parent workshops
- Open communications
- Training for staff
- Support for staff and students with protected characteristics eg LGBT+
- Clear policies tackling discrimination, bullying, and behaviour, and adhere to the Teachers' Standards

SOURCES

The Department for Education has published statutory guidance (June 2019) regarding the implementation of Relationship Education, Relations and Sex Education (RSE) and Health Education in all schools across England by 2020. Schools are encouraged to implement the curriculum from 2019.

“Pupils should be able to understand the world in which they are growing up which means understanding that some people are LGBT, that they should be respected in British society, and that the law affords them and their relationship recognition and protection (DFE 2019).

The **Equality Act 2010** states that it is against the law to discriminate against anyone because of:

- Age
- Disability

- Gender reassignment
- Marriage and civil partnership
- Pregnancy or maternity
- Race
- Religion or belief
- Sex
- Sexual orientation

The **Public Sector Equality Act** (April 2011) states that all public bodies have to consider all individuals when carrying out their day to day work. It also requires that public bodies:

- Have due regard to the need to eliminate discrimination
- Advance equality of opportunity
- Develop good relations between different people

Department for Education RSE Guidance (Draft, Feb 2019, June 2019) Page 15

36. In teaching Relationships Education and RSE, schools should ensure that the needs of all pupils are appropriately met, and that all pupils understand the importance of equality and respect. Schools must ensure that they comply with the relevant provisions of the Equality Act 2010 under which sexual orientation and gender reassignment are amongst the protected characteristics.

37. Schools should ensure that all of their teaching is sensitive and age appropriate in approach and content. At the point at which schools consider it appropriate to teach their pupils about LGBT, they should ensure that this content is fully integrated into their programmes of study for this area of the curriculum rather than delivered as a standalone unit or lesson. Schools are free to determine how they do this, and we expect all pupils to have been taught LGBT content at a timely point as part of this area of the curriculum.

NEU statement April 2019. Extract:

15) Appendix 5: FAQs answered by the Department for Education

Below, the DfE have explained some of the common misconceptions around the subjects.

Q: Will my child's school have to consult with me before teaching these subjects?

A: Schools will be required to consult with parents when developing and reviewing their policies for Relationships Education and RSE, which will inform schools' decisions on when and how certain content is covered. Effective consultation gives the space and time for parents to input, ask questions, share concerns and for the school to decide the way forward. Schools will listen to parent's views, and then make a reasonable decision as to how they wish to proceed. What is taught, and how, is ultimately a decision for the school and consultation does not provide a parental veto on curriculum content.

A school's policies for these subjects must be published online, and must be available to any individual free of charge. Schools should also ensure that, when they consult parents, they provide examples of the resources they plan to use, for example the books they will use in lessons.

Q: Will my child be taught sex education at primary? This is too young.

A: We are not introducing compulsory sex education at primary school.

We are introducing Relationships Education at primary, to put in place the building blocks needed for positive and safe relationships of all kinds. This will start with family and friends, how to treat each other with kindness, and recognising the difference between online and offline friendships.

Some primary schools choose to teach sex education (which goes beyond the existing national curriculum for science), and in those instances we recommend you discuss this with the school to understand what they propose to teach and how. If you continue to have concerns, you have an automatic right to withdraw your child from these lessons.

Q: Does the new Relationships Education and RSE curriculum take account of my faith?

A: The subjects are designed to help children from all backgrounds build positive and safe relationships, and to thrive in modern Britain.

In all schools, when teaching these subjects, the religious background of pupils must be taken into account when planning teaching, so that topics are appropriately handled. Schools with a religious character can build on the core content by reflecting their beliefs in their teaching.

In developing these subjects, we have worked with a number of representative bodies and faith organisations, representing all the major faith groups in England. Several faith organisations produce teaching materials that schools can choose to use.

Q: Do I have a right to withdraw my child from Relationships and Sex Education?

A: Parents will have a right to withdraw their child from sex education delivered as part of RSE in secondary schools which, unless there are exceptional circumstances, should be granted up to three terms before their child turns 16. At this point, if the child themselves wishes to receive sex education rather than be withdrawn, the school should make arrangements for this to happen in one of the three terms before the child turns 16 - the legal age of sexual consent.

There is no right to withdraw from Relationships Education at primary or secondary as we believe the contents of these subjects – such as family, friendship, safety (including online safety) – are important for all children to be taught.

Q: Has the government listened to the views of my community in introducing these subjects?

A: A thorough engagement process, involving a public call for evidence and discussions with over 90 organisations, as well as the public consultation on the draft regulations and guidance, has informed the key decisions on these subjects. The consultation received over 11,000 responses from teachers, schools, expert organisations, young people and parents – these responses have helped finalise the statutory guidance as well as the regulations that have been laid in Parliament.

Q: Will these subjects promote LGBT relationships?

A: No, these subjects don't 'promote' anything, they educate.

Pupils should be taught about the society in which they are growing up. These subjects are designed to foster respect for others and for difference, and educate pupils about healthy relationships. RSE should meet the needs of all pupils, whatever their developing sexuality or identity – this should include age-appropriate teaching about different types of relationships in the context of the law.

Pupils should receive teaching on LGBT relationships during their school years - we expect secondary schools to include LGBT content. Primary schools are enabled and encouraged to cover LGBT content if they consider it age appropriate to do so, but there is no specific requirement for this. This would be delivered, for example, through teaching about different types of family, including those with same sex parents.

Q: Will teachers receive training before delivering these subjects?

A: The department is committed to supporting schools to deliver these subjects to a high standard. We know that training is a priority for teachers and we will be consulting with teachers, trade unions and other key stakeholders over the coming months on how we structure the training.

In addition, we are encouraging schools to act as early adopters for this curriculum and to start teaching the subjects from September 2019. To help early adopter schools, we will provide further advice on how they can improve their practice. Lessons learned from the early adopters and best practice from schools will be shared with all schools from September 2020.
